Pursuant to Title 5 Business Licenses, Taxes and Regulations of the Rio Dell Municipal Code (RDMC), every person as defined in Section 5.05.010 of the RDMC, transacting and carrying on any business in the City of Rio Dell shall obtain a business license from the City. The annual licensing fee shall be based on the proceeding calendar years gross receipts or estimated gross receipts based on the following classification and rates:

B	In excess of \$ 30,000.00	\$61.00*

Payment must be made before July 31st of each year or a penalty will be assessed pursuant to Section 5.05.120 of the Rio Dell Municipal Code.

“Address of Convenience” means non-residential activities associated with any profession, occupation or hobby, having no employees, receiving no more than one delivery per day at the residence and utilizing a private residence only for receiving mail, phone calls and related record keeping (typically a mobile business). No more than one truck or other motor vehicle no larger than one ton and shall be permitted at the site of the Address of Convenience.

“Home Occupation” means the conduct of an art or profession, the offering of a service on the conduct of a business, or the manufacture of handicraft products in a dwelling in accordance with the regulations prescribed in Chapter 17.30 RDMC.

“Cottage Industry” means the on-site production of goods by hand manufacturing in an enclosed building which involves only the use of hand tools or domestic mechanical equipment or a single kiln, and the incidental direct sale to consumers of only those goods produced on-site by the inhabitants of the property and which is clearly incidental and secondary to the residential use of the property. Typical uses include, but are not limited to, ceramic studios, custom jewelry, wood-working, small furniture and cabinet manufacturers or metal fabrication and welding. No more than one truck or other motor vehicle no larger than one ton shall be permitted at the site of the Cottage Industry.

I UNDERSTAND THAT THIS IS AN APPLICATION FOR A BUSINESS LICENSE AND THAT THE COMPLETION OF THE APPLICATION DOES NOT CONSTITUTE APPROVAL AND THE ISSUANCE OF A BUSINESS LICENSE TO OPERATE A BUSINESS IN THE CITY OF RIO DELL. THE BUSINESS LICENSE IF APPROVED IS FOR THE FISCAL YEAR, JULY 1ST THROUGH JUNE 30TH.

I declare under penalty of perjury, that the information contained herein is true and correct and that I/we qualify as a Class A or Class B business based on the proceeding calendar years gross receipts or estimated gross receipts. I am, am not the property owner of the parcel. If the applicant is not the property owner, the property owner must also sign the application.
